The Board will consider the following items:

- 1) A request by Bill Yount Signs, for one variance at 12215 Manchester Road, Raising Cane's Chicken Fingers., to raise the current monument sign 2' higher, to be a total of 80 sqft. Section 410.050. A.2 limits ground signs to 30 sqft on lots less than 3 acres in size in the Commercial Zoning District.
- 2) A request by Paul Emery, property owner, for one variance at 8 Topping Lane, to remove carport and replace with garage. The proposed addition would encroach 9'9" into the side yard setback, establishing a 10'3" side yard. Section 404.005 B.3 requires a 20' rear yard setback in the A-Residential Zoning District.
