

## NOTICE OF PUBLIC HEARING 2020 REAL ESTATE TAX RATE CITY OF DES PERES, MISSOURI

**Notice is hereby given**, that the Board of Aldermen of the City of Des Peres, Missouri, will hold a Public Hearing beginning at 7:00 P.M. on Monday, September 14, 2020, in the Council Chambers at Des Peres Government Center, 12325 Manchester Road, Des Peres, MO 63131, on the proposed ad valorem tax rate to be imposed on real and personal property for 2020. Values in this notice are from the St. Louis County Assessment Rolls certified July 1, 2020. Post Board of Equalization Assessment Rolls are expected to be released mid-September and will be used to calculate the final tax rate.

## **Compliance with Reassessment Statute**

The tax rate is set in accordance with the provisions of Section 22 of Article X of the State Constitution and Section 137.073.2, RSMO 1994, which allows a 2020 Real Estate Tax Rate as follows:

## Compliance with Section 67.110, RSMO

The tax rate is set to produce the revenue which the Budget for the 2020 Fiscal Year shows to be required from the real estate and personal property tax. The tax rate to be levied is determined by dividing the amount of revenue required in the budget by the total assessed value multiplied by one hundred to express the tax rate in cents per \$100 of assessed value:

The 2020 Tax Rate on Real and Personal Property will be proposed at the tax rate ceiling with consideration given to voluntarily reduce the rate for the General Fund from the levy authorized by statute to zero (\$0.00).
