**ALDERMANIC REPORT**

In absence of Alderman Concagh, Director Schaffer reported that at the March Planning & Zoning Commission, the Commission recommended approval for a rezoning and preliminary subdivision at Blattner Farm. A public hearing for the rezoning has been scheduled for April 22, 2019.

Director Schaffer reported that Rosalita has applied for a permit to have a Cinco de Mayo Celebration on May 5, 2019.

Director Schaffer stated that the board was addressed requesting that they consider amending the ordinance to allow back yard chickens.

### **DIRECTOR'S REPORT**

Director Schaffer provided a handout of the Parks and Recreation Department Activities in March 2019. Director Schaffer highlighted main activities from the handout such as; the outdoor pool painting, mulching around the Lodge, the upcoming Lodge storage garage and the native plant burn along the shoreline of the lake at Des Peres Park and the two small rain gardens at Harwood Park.

Director Schaffer announced that Jayne Lundstrom, Recreation Supervisor, is retiring on May 1, 2019 after 18 years of service. Jayne will be greatly missed.

### **OLD BUSINESS**

#### a) Des Peres Park Tennis Complex Update

Director Schaffer provided a drawing of the Des Peres Tennis Complex project and reported that the Board of Alderman approved the plan to use a mixture of cooperative purchasing and traditional bidding for the project. We will need to go out to bid for the demolition and earthwork, after working with MSD on the storm water plan for the project. Director Schaffer also reported that 21 trees need to be removed due to construction. Signs will be posted to inform park users why the trees are being removed. #### b) Medicare Healthcare Fitness Plans at The Lodge

Director Schaffer provided information on the SilverSneakers program at The Lodge and reviewed membership numbers with the Commissioners. The Commission discussed the Renew Optum program and a motion was made to not offer it at the Lodge.
