**ROLL CALL**

Commissioner Chair Beermann opened the meeting. Administrative Assistant Llorián commenced with the roll call. The entire commission was present.

**HEAR CITIZENS**

**APPROVAL OF MINUTES**

Commissioner Sullivan made a motion to approve the minutes of the April 2, 2018 meeting. Commissioner Ashcraft seconded the motion, and it passed unanimously.

**ALDERMANIC REPORT**

Alderman Sansone stated the Board of Aldermen held a special meeting in regards to Rosalita's Restaurant Cinco de Mayo celebration. Capt. Hall stated they had only one EMS call at the special event. Chief Krumm concluded that celebration went very well.

## **BUDGET**

Chief Krumm stated that the department budget is looking good for the exception for building maintenance. He stated that the building maintenance budget is over due to CALEA requirements. He concluded that he will request a budget adjustment mid-year to amend the budget in this category.

## **NEW BUSINESS**

### **Law Enforcement Best Practices**

Chief Krumm stated police departments that are desiring to remain members of St. Louis Area Police Chiefs Association (SLAPCA) are required to meet Law Enforcement Best Practice Agreement set-up by the organization, be certified by the Missouri Police Chiefs Association or accredited by CALEA.. He stated that Des Peres meets the requirements and by being currently certified by the Missouri Police Chiefs Association. The department is also finishing the process to achieve CELEA accreditation in 2019. Chief Krumm concluded that he will sign the agreement and forward the agreement to City Hall for Board of Alderman approval and the Mayor's signature.

## **OLD BUSINESS**

### **Resident Camera Program**

Chief Krumm stated the department has not yet moved forward on the resident camera program. He stated the department plans to put it in a newsletter later this year to spur interest. He concluded that several departments up north have tried to get residents to sign-up but none very few have shown an interest mainly due to the possibility of being required to appear in court.

### **Insurance Services Office Audit for 2018**

Captain Hall stated he is continuing the documentation for ISO and this month he is conducting flow tests of certain hydrants to compare with the 2004 flow test numbers. He added that the department fire standard operating guidelines are being reviewed and revised as needed. He concluded that the period of documentation for the ISO audit runs from July 1, 2017, to June 30, 2018.

### **CALEA Update**

Lt. Willoughby stated that the CALEA accreditation process is moving along very well. He stated that two procedures need to be updated. He stated that he was asked to participate in Kirkwood's mock assessment. Lt Willoughby concluded that he will be attending the CALEA conference in July 25, 2018.

## **DISCUSSION**

Chief Krumm stated there was a good turnout for the Monster Machine Event at Des Peres Park on Saturday. He stated that Rosalita's Cinco de Mayo celebration went very well with no major incidents.

He added that Michael Clayborne won a silver medal in the BBQ event at Shaw Park in Clayton to benefit the Backstoppers and Responder Rescue.

Chief Krumm has been contacted by a consultant working for Anheuser Busch in reference to a possible special event being held in Des Peres that would include the Clydesdales being driven down Manchester Road between Schnucks and Dierberg's which would require part of Manchester Road to be closed. Chief Krumm advised the consultant to contact Missouri Department of Transportation (MoDOT) regarding the street closure as that section of Manchester Road falls under their jurisdiction and a permit from them would be required. Chief Krumm will update the commission as details become available.

Commissioner Ashcraft stated that the resident from Frontenac that caused all the issues with golf carts has moved. Chief Krumm added that there has been no complaints regarding golf carts lately.

Commissioner Lund asked if the department has considered the purchase of body cameras. Chief Krumm stated not at the moment but anticipated it might be a purchase in the future.

**ADJOURNEMENT**

Commissioner Ashcraft made a motion to adjourn the meeting. Commissioner Lund seconded the motion, and it passed unanimously. The meeting adjourned at 7:38 p.m.
