#### a) Des Peres Park Tennis Complex Update

Director Schaffer presented a slideshow of the project and reviewed the timeline. Director Schaffer reported that at the request of the Board of Alderman, Planning Design Studio (PDS) met and discussed the project budget with Vee-Jay Cement Contractors and McConnell and Associates to clarify items regarding their individual bid pricing. Based upon those discussions, both contractors have offered the City credits of 1%. If the Board of Alderman approves the changes to the budget on June 17th the contractors will proceed.
