VIOLATIONS BUREAU SCHEDULE OF OFFENSES AND FINES EFFECTIVE _June 1st, 2019_____

Pursuant to 479.050, RSMo, Supreme Court Rule 37.49, the undersigned Municipal Judge of the City of Des Peres hereby orders that the following designated offenses shall be payable to the City of Des Peres Municipal Court. Unless otherwise indicated, no court appearance is necessary.

This schedule is divided into two parts. Part I designates the City of Des Peres Municipal Court Traffic Violation Schedule for moving violations (points). Part II designates the City of Des Peres Municipal Court Traffic Violation Schedule for non-moving violations (no points).

COURT COSTS:

In accordance with Missouri statutes and ordinances adopted by the City, total court costs shall be \$33.50/ This includes: Basic Court Costs of \$12.00/ Crime Victim's Compensation Surcharge of \$7.50/ Peace Officer's Standard Training Fund of \$2.00/ Battered Women's Shelter \$2.00/ Live Scan Fingerprinting \$2.00/ Law Enforcement Training Fund of \$1.00 and Court Automation fund \$7.00


