MINUTES BOARD OF ALDERMEN AUGUST 9, 2021 DES PERES GOVERNMENT CENTER

The regular meeting of the Board of Aldermen of the City of Des Peres, Missouri met at the Des Peres Government Center, 12325 Manchester Road 63131, commencing at 7:00 P.M. on Monday, August 9, 2021.

ROLL CALL

The City Clerk took roll call with the following elected officials present: Alderman Barrett, Alderman Osherow, Alderman Pound, Alderman Kleinschmidt, Alderman Concagh, and Alderman Fitzpatrick. Mayor Becker was also present.

Alderman Kleinschmidt attended the meeting via zoom.

Staff members present included the City Administrator, Assistant City Administrator, City Attorney, Director of Finance, Director of Public Safety, Director of Public Works, Director of Parks and City Clerk.

At this time, those present rose for the Pledge of Allegiance.

PUBLIC HEARING - NONE

CITIZEN COMMENTS - Petition for "The Happy Bee Music Festival in Des Peres"

Petitioner, Joe Oates, 1142 Vinetta Dr., informed the Mayor and Aldermen that he is going to organize a charitable event which he has titled "The Happy Bee Music Festival in Des Peres" to be held Friday, September 3rd. The event is to be staged at the picnic shelter and gazebo at Des Peres Park. Mr. Oates stated the purpose of this event is to raise funds which will then be used for children who cannot afford music instruments. Mr. Oates stated he will have everything covered - trash, parking and insurance.

City Attorney, Chris Graville stated per the City of Des Peres Ordinances, Des Peres Park cannot be used for such event.

Mr. Oates stated the County gets to do events in Des Peres Park, maybe he could get them to do the charitable event. The Board clarified that the County does not put on events in Des Peres Park that the City of Des Peres does.

City Administrator, Doug Harms stated Mr. Oates was not truthful on his Parks application to rent the pavilion. Mr. Oates wrote down he was only going to have 100 guests and that it was a personal event. However, Mr. Oates is planning on having thousands of people attend "The Happy Bee Music Festival in Des Peres".

Mr. Oates stated the next time the City of Des Peres holds an event in Des Peres Park, he will protest if he is unable to hold this charitable event.

She is a 15+ year resident of Des Peres and mother of 5 daughters. She has been an active volunteer at St Gerard Majella and The Cardinal Glennon Children's Hospital Guild.

Alderman Fitzpatrick made a motion, seconded by Alderman Barrett to approve the appointment of Lori Hartman to the Audit and Finance Committee for a term ending June 30, 2023. A roll call vote was taken with the following results: Alderman Barrett, "AYE", Alderman Concagh "AYE" Alderman Fitzpatrick, "AYE", Alderman Kleinschmidt, "AYE", Alderman Osherow, "AYE", Alderman Pound, "AYE". Motion passed 6-0.

2. B21-2921 An Ordinance Amending Ordinance 2897 Relating to Employee Compensation to Establish the Position of Parks & Recreation Manager (Introduction)

Alderman Kleinschmidt Read Bill 21-2921 for the first time.

Staff requested to waive the rules and ask that Bill 21-2921 be read for a second time, for passage and approval at tonight's meeting.

Alderman Kleinschmidt made a motion, seconded by Aldermen Concagh to have the second reading of Bill 21-2921 for passage and approval to take place at tonight's meeting. Alderman Concagh Read Bill 21-2922 for the first time.
