# MINUTES BOARD OF ALDERMEN NOVEMBER 22, 2021 DES PERES GOVERNMENT CENTER

The regular meeting of the Board of Aldermen of the City of Des Peres, Missouri met at the Des Peres Government Center, 12325 Manchester Road 63131, commencing at 7:00 P.M. on Monday, November 22, 2021.

#### **ROLL CALL**

The City Clerk took roll call with the following elected officials present: Alderman Osherow, Alderman Pound, Alderman Kleinschmidt and Alderman Fitzpatrick. Mayor Becker was also present.

Alderman Barrett and Alderman Concagh were absent with excuse.

Staff members present included the City Administrator, Assistant City Administrator, City Attorney, City Clerk, Director of Finance, Director of Public Safety, Director of Public Works, and Director of Parks and Recreation.

# PUBLIC HEARING - 2022 Fiscal Year Budget

Mayor Becker stated that there was a Public Hearing relating to adoption of the 2021 Fiscal Year Budget.

#### **Unfinished Business –**

a. B21-2929 An Ordinance Adopting New Ward Boundaries, Repealing All Ordinances In Conflict therewith and Effective Date (Second Reading)

Alderman Fitzpatrick read B21-2929 for the second time.

Alderman Fitzpatrick made a motion, seconded by Alderman Kleinschmidt to approve B21-2929. A roll call vote was taken with the following results: Alderman Fitzpatrick, "AYE", Alderman Kleinschmidt, "AYE" Alderman Osherow, "AYE", Alderman Pound, "AYE". Motion passed 4-0.

b. B21-2930 An Ordinance Establishing Employee Compensation Effective January 1, 2022 and Repealing All Ordinances in Conflict Therewith (Second Reading)

Alderman Kleinschmidt read B21-2930 for the second time.

Alderman Kleinschmidt made a motion, seconded by Alderman Osherow to approve B21-2930.A roll call vote was taken with the following results: Alderman Fitzpatrick, "AYE", Alderman Kleinschmidt, "AYE" Alderman Osherow, "AYE", Alderman Pound, "AYE". Motion passed 4-0.

c. B21-2931 An Ordinance Adopting and Enacting the Mechanical, Electrical,

Plumbing and Explosives Codes of St Louis County as the Mechanical, Electrical, Plumbing and Explosives Codes of the City of Des Peres; amending the Municipal Code Accordingly; and Repealing All Ordinances in Conflict Therewith (Introduction)

Alderman Pound read B21-2931 for the second time.

Alderman Pound made a motion, seconded by Alderman Fitzpatrick to approve B21-2931.A roll call vote was taken with the following results: Alderman Fitzpatrick, "AYE", Alderman Kleinschmidt, "AYE" Alderman Osherow, "AYE", Alderman Pound, "AYE". Motion passed 4-0.

#### **NEW BUSINESS -**

a. B21-2932An Ordinance Approving a Lot Consolidation Plat Containing 1.49
Acres Located at 13239-13231 Manchester Road (Introduction)

Alderman Kleinschmidt read B21-2932 for the first time.

Mayor Becker announced that this bill would be held over until the December 13, 2021 meeting for Public Hearing and second reading/consideration for passage and approval at that time.

b. B21-2933 An Ordinance Approving a Master Development Plan for a 1.49 Acre Tract of Land at 13239-13231 Manchester Road; Issuing a Conditional Use Permit to Shake Shack for Operation of a Restaurant with Drive-Thru Service; and Repealing all Ordinances in Conflict Therewith (Introduction)

Alderman Fitzpatrick read B21-2933 for the first time.

Mayor Becker announced that this bill would be held over until the December 13, 2021 meeting for Public Hearing and second reading/consideration for passage and approval at that time.

c. R21-3519 Adopting the Budget for the Fiscal Year Beginning January 1, 2022 (Hold for December 13<sup>th</sup> Regular Meeting)

Alderman Pound read R21-3519.

Alderman Pound made a motion, seconded by Alderman Fitzpatrick to approve R21-3519. A roll call vote was taken with the following results: Alderman Fitzpatrick, "AYE", Alderman Kleinschmidt, "AYE" Alderman Osherow, "AYE", Alderman Pound, "AYE". Motion passed 4-0.
